Rules & Regulations Governing the Occupancy & Use of Campgrounds at Sierra Brooks

Sierra Brooks owns and maintains a no-hookup Campground for the overall enjoyment of recreation in the area. The following are common sense rules meant to control actions that cause damage to natural resources and facilities as well as actions that cause unreasonable disturbances for park visitors and residents that live nearby. Observance of these rules will make your visit and the visit of others safe, pleasant, and enjoyable.

Camping and normal recreational season of the campground is April 1st through September 30th. It is open to members only and their immediate family. **Maximum stay is 14 days** without express written permission of the Sierra Brooks Board of Directors. RV self-contained units are permitted (campers, motor homes, 5th wheel units, travel trailers). NO CAMPING PERMITTED outside of the dates listed above due to the restrooms and campground being winterized.

PROHIBITED ACTS THAT APPLY

SANITATION

- 1. Failing to dispose of all garbage, including paper, cans, bottles, sewage, waste water, ect. by removal from the site or area.
- 2. Cleaning or washing any personal property, fish, animals or food at a hydrant or at a water faucet not specifically provided for the purpose.
- 3. Placing in or near a stream, or other water any substance which does or may pollute the stream or water supply.
- 4. Depositing in any toilet, toilet vault or plumbing fixture any bottle, can, rag, metal, wood, stone, flammable liquid or other substance which could damage or interfere with the operation or maintenance of the fixture.
- 5. Depositing any body waste except into the receptacles provided for the purpose.
- 6. Dumping or leaving in a refuse container, dump or similar facility, refuse, debris or litter brought as such from private property or from holding tanks.
- 7. Possessing or leaving refuse, debris or litter in an exposed or unsanitary condition.

OPERATION OF VEHICLES

- 1. Operating or parking a motor vehicle or trailer except in places developed for this purpose.
- 2. Operating a motor bike, motorcycle or other motor vehicle for any purpose other than entering or leaving the site.
- 3. Placing a vehicle or other object in such a manner that it is an impediment or hazard to the safety or convenience of any person.
- 4. Blocking, restricting or otherwise interfering with the use of the road, trail or gate.

BUILDING FIRES & FIRE HAZARDS

- 1. Having a fire without a fire permit from Sierra County. And, having a fire during a season of "no campfires."
- 2. Building, attending, maintaining or using a fire outside of the fire ring provided by the park for such purpose or outside of a stove, grill or fireplace. *** Clear all vegetation away from the fire ring (remove all flammable materials such as needles, leaves, sticks, etc.)
- 3. Discharging or igniting a firecracker rocket or other firework or explosive.
- 4. Leaving a fire without completely extinguishing.

ABANDONED PERSONAL PROPERTY

1. Abandoning a vehicle, animal or personal property is strictly prohibited.

Rules & Regulations Governing the Occupancy & Use of Campgrounds at Sierra Brooks PROHIBITED ACTS THAT APPLY continued...

PETS AND ANIMALS

- 1. Bringing in or possessing an animal other than a seeing eye dog, unless it is crated, caged or upon a leash not longer than six feet, or otherwise under physical restrictive control.
- 2. Leaving dog waste. Pick up all dog poop and remove it from the premises.

CAMPING

- 1. Placing, maintaining or using camping equipment except in a place specifically designated or provided for such equipment.
- 2. Without written permission of the HOA such permission to be secured from the managers at the lodge.
- 3. Cutting, killing, destroying, girdling, chipping, chopping, boxing, injuring or otherwise damaging or removing any timber, tree or other forest product.
- 4. Mutilating, defacing, removing, disturbing, injuring or destroying any natural feature or any property.

PUBLIC BEHAVIOR

- 1. Engaging in fighting or in threatening or abusive behavior.
- 2. Inciting or participating in a riot.
- 3. Making unreasonable noise.

BUSINESS ACTIVITIES

1. Selling or offering for sale any merchandise, conducting any kind of business enterprise, or performing any kind of work, and/ or posting, placing or erecting any related paper, notice, advertising material, sign or similar matter.

AUDIO DEVICES, NOISE, & HAZARDS

- 1. Operating or using in or near an assigned site, any device which produces noise such as a radio, television, musical instrument, motor or engine in such a manner and at such a time so as to unreasonably disturb any person.
- 2. Discharging or igniting a firecracker rocket or other firework or explosive.
- 3. Discharging a firearm or any implement capable of taking human life, causing injury or damaging property.

OTHER PROHIBITED ACTS

- 1. Constructing, placing or manufacturing any kind of road, trail, structure, fence, enclosure, communication equipment or other improvement without a permit.
- 2. Occupying any portion of the site for other than recreation purposes.
